For this purpose of this form, "Virtual assets" or "VA" or "Token" means: (a) any "virtual assets" as defined in section 53ZRA of the AMLO; and (b) any security token. "VA-related products" refers to investment products which: (a) have a principal investment objective or strategy to invest in virtual assets; (b) derive their value principally from the value and characteristics of virtual assets; or (c) track or replicate the investment results or returns which closely match or correspond to virtual assets.
