

**Personal Information Collection Statement concerning Hong Kong Investor Identification Regime (HKIDR) and Over-the-counter Securities Transactions Reporting Regime (OTCR)**

**Processing of Personal Data as part of the HKIDR and OTCR**

Your company acknowledge and agree that we, MIB Securities (Hong Kong) Limited, may collect, store, process, use, disclose and transfer personal data relating to your company as the account holder (including its CID and BCAN(s)) as required for us to provide services to your company in relation to securities listed or traded on the Stock Exchange of Hong Kong (SEHK) and for complying with the rules and requirements of SEHK and the Securities and Futures Commission (SFC) in effect from time to time. Without limiting the foregoing, this includes –

- (a) disclosing and transferring its company data (including CID and BCAN(s)) to SEHK and/or the SFC in accordance with the rules and requirements of SEHK and the SFC in effect from time to time;
- (b) allowing SEHK to: (i) collect, store, process and use its company data (including CID and BCAN(s)) for market surveillance and monitoring purposes and enforcement of the Rules of the Exchange of SEHK; and (ii) disclose and transfer such information to the relevant regulators and law enforcement agencies in Hong Kong (including, but not limited to, the SFC) so as to facilitate the performance of their statutory functions with respect to the Hong Kong financial markets; and (iii) use such information for conducting analysis for the purposes of market oversight; and
- (c) allowing the SFC to: (i) collect, store, process and use its company data (including CID and BCAN(s)) for the performance of its statutory functions including monitoring, surveillance and enforcement functions with respect to the Hong Kong financial markets; and (ii) disclose and transfer such information to relevant regulators and law enforcement agencies in Hong Kong in accordance with applicable laws or regulatory requirements.

Your company also agrees that despite any subsequent purported withdrawal of consent by your company, its company data may continue to be stored, processed, used, disclosed or transferred for the above purposes after such purported withdrawal of consent.

*Note: The terms “BCAN” and “CID” used in this content shall bear the meanings as defined in paragraph 5.6 of the Code of Conduct for Persons Licensed by or Registered with the Securities and Futures Commission.”*

**Consequences of failing to provide Personal Data or Consent**

Failure to provide us with personal data or consent of your company as described above may mean that we will not, or will no longer be able to, as the case may be, carry out its trading instructions or provide your company with securities related services (other than to sell, transfer out or withdraw your existing holdings of securities, if any)

## 香港投資者識別碼制度及場外證券交易匯報制度個人資料收集聲明

處理個人資料作為香港投資者識別碼制度及場外證券交易匯報制度的一部分

閣下明白並同意，我們，馬銀證券（香港）有限公司為了向閣下提供與在香港聯合交易所（聯交所）上市或買賣的證券相關的服務，以及為了遵守不時生效的聯交所與證券及期貨事務監察委員會（證監會）的規則和規定，我們可收集、儲存、處理、使用、披露及轉移與閣下有關的個人資料（包括閣下的客戶識別信息及券商客戶編碼）。

3. 允許證監會：(i)收集、儲存、處理及使用閣下的個人資料（包括客戶識別信息及券商客戶編碼），以便其履行法定職能，包括對香港金融市場的監管、監察及執法職能；及(ii)根據適用法例或監管規定向香港相關監管機構和執法機構披露及轉移有關資料。

閣下亦同意，即使閣下其後宣稱撤回同意，我們在閣下宣稱撤回同意後，仍可繼續儲存、處理、使用、披露或轉移閣下的個人資料以作上述用途。
